Terms of Use ("Terms")

Please read these Terms of Use ("Terms", "Terms of Use") carefully before using AAA.orzone.com or AAA.ortrac.com websites ("AAA" refer to any subdomains including www, test, support etc) and group the Ortrac Scholar mobile application (the "Service") operated by Ortrac AB, Gothenburg, Sweden (part of Orzone group ("us", "we", or "our" also refer to any sister-, parent-, subsidiary, affiliated or otherwise controlled company in the company group)).

Your access to and use of the Service is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Service.
